4 Amendments on the GA Agenda

How we got here

The UUA by-laws require a review of Article II, our Principles and Purposes section, every 15 years. The current Article II, which includes the purposes of the UUA as well as our 7 principles, were adopted in 1985. A revision was rejected by the delegates in 2009. The latest version passed its first vote "to continue the process" at GA 2023, and a vote this year is needed to adopt or reject the new Article II. These 4 amendments have gotten approval to be on this year's agenda; delegates will vote on amendments first, then on Article II as a whole.

Equity: Every person is inherently worthy

Clean version:

41 Equity. We declare that every person is inherently worthy and has the right to flourish with 42 dignity, love, and compassion.

Peace as a UU Value

Clean version:

20 Inseparable from one another, our shared values are:

44 and inclusive communities.

Peace. We dedicate ourselves to peaceful conflict resolution at all levels.

We covenant to a [sic] promote a peaceful world community with liberty and human rights for all. Whenever and wherever possible we will support nonviolent means to achieve peace.

Clean version:

41 Equity. We declare that every person has the right to flourish with inherent dignity and 42 worthiness.

43 We covenant to use our time, wisdom, attention, and money to build and sustain fully 44 accessible and inclusive communities. Equity calls us to listen, understand, respect, and respond to one another.

Reason and the Responsible Search for Truth and Meaning

Clean version:

After Line 44

Reason. We search for truth and meaning, informed by reason, evidence, and the results of science, motivated by wonder, curiosity, and compassion.

We covenant to listen to and respect the views of others, and to remain open to new ideas.

Article II Revision Vote: FINAL!

How Did We Get Here?

Article II of the UUA by-laws is scheduled to be reviewed every 15 years. Votes on previous suggested reviews of Article II were held in 1985 (accepted by delegates) and 2009 (rejected, narrowly). The process this time started at GA 2021; at GA 2022 in Portland, the UUA Article II Study Commission presented its first draft of a possible revision, and there was time for discussion. At GA 2023, a new version, created with input from UUs through discuss.uua.org and other means, was presented, and delegates voted to "accept" the results: largely understood, based on language used by UUA leaders, to mean "continue the dialogue".

Where Are We Now?

The change from Principles and Purposes to Values—complete with 6-petalled graphic, both loved and hated—was accepted, though the removal of the current principles was of concern to many. Others found that same removal liberating.

What Next?

This year at virtual GA will be the final vote on the updated Article II Commission proposal. Some folks are disturbed that this will be done during an all-virtual GA, eliminating the possibility of face-to-face "hallway conversations"—whereas others see that as removing undue influence by those privileged to attend in person, making access more equitable, if limited.

Talk with friends, family, and other UUs; make sure that they know about the amendments, and participate in your congregation, fellowship, or society's (CFS's) formal discussion—or lead one, if none are planned! Send informed delegates—or be one yourself!

If the proposal is rejected by delegates this year, the process will stop and the current language retained until the next scheduled review in 15 years.

- Collective bargaining agreements for represented stores and partners.
- A fair process for workers to organize.
- The resolution of litigation, including brand litigation.

Letters!

UUJEC gets requests from various organizations to sign on to a variety of letters. Independently-active board members also suggest sign-ons for consideration by the UUJEC. Here we list our most recent signatures:

- ◆ Food & Water Watch/Leadership Counsel for Justice & Accountability call for Governor Newsom and the California Air Resources Board (CARB) to take concrete action to adopt new rules that align the Low Carbon Fuel Standard with California's environmental justice commitments.
- ◆ The John Muir Project, with more than 200 organizations and 200 leading scientists, urge President Joe Biden to issue an executive order halting logging in all mature and old-growth (MOG) forests on federal lands. This appeal calls for immediate, robust executive action to protect our nation's MOG forests to mitigate the climate crisis and protect biodiversity.
- ◆ Letter to Energy Secretary Granholm requesting that Clean Hydrogen Hub Demonstration funding not be used to prolong fossil fuels; that clean hydrogen be defined in such a way to avoid greenwashing by fossil-fuel companies.
- supported Dr. Chris Jones for an EPA subcommittee on water quality
- asking for a pathway to citizenship for immigrants and cuts to ICE and CBP,
- Energy Democracy Project's letter telling FEMA to prioritize communities, not centralized power, in Puerto Rico,
- Support South Africa's Genocide Convention Case against Israel at the International Court of Justice.
- An interfaith letter to support Annunciation House in Texas, which provides services to arriving immigrants.

Although UUJEC hasn't formally endorsed Radical Elders' complete program, we did cosponsor their screening of Cooked last year. We certainly recommend their March 16th Day of Action program on Medicare (dis)Advantage. We have all seen the ads by private companies, which imply that they offer more than the public program. The Day is live and on Zoom from 12 NOON to 8 P.M. There will also be music, a writing workshop, and visioning—every program will have an associated action.
